# Proposal Activism Grants distribution 2020 ABC committee



The activism grants committee has processed all requests and their corresponding proof for 2020. Based on the total number of grants available, the current model of OS activism grants and the details provided to them by the associations, a division has been made which will be elaborated upon in this document. Please note that fewer grants have been distributed in category A-D due to the board grants added to the distribution. For more information on this, see page 5.

#### Category A – Large study trips

For category A, we received ten requests for grants, but the corona pandemic has had its effect on the possibilities for travel, and so several study tours have either been postponed or cancelled. All study trips that now take place in a later calendar year than 2020 will have to re-request grants for that year. For those study trips that have been cancelled, a special corona guideline has been created. This guideline specifies that cancelled trips can still receive a percentage of their total grants based on the progress that was made before cancellation. The guideline was followed as much as possible by the ABC. In total, a lower number of grants is available in this category due to the distribution of additional board grants as mandated by the Student Union.

#### Category B – Symposia

For category B, we received fifteen requests for grants. All symposia that now take place in a later calendar year than 2020 will have to re-request grants for that year. For those symposia that have been cancelled, a special corona guideline has been created. The guideline was followed as much as possible by the ABC. Most symposia in this category have actually taken place, with the exception of Scintilla, who will receive a percentage of their total grants based on the original planned date of the symposium.

### Category C – Small study trips and other substantial study related activities

Category C is where smaller study trips, which stay within Europe, business courses or other relevant study related activities are reviewed. For this category, we received seventeen requests. All trips that now take place in a later calendar year than 2020 will have to re-request grants for that year. For those trips that have been cancelled, a special corona guideline has been created. Activities will receive a percentage of their total grants based on the original planned departure date of the trip. The guideline was followed as much as possible by the ABC. In total, a lower number of grants is available in this category due to the distribution of additional board grants as mandated by the Student Union.

### Category D – Miscellaneous

For this category, we received seven requests. Due to the total number of grants beings lower than expected, some shuffling has already been required, and very few grants were left for category D. As the board of Ideefiks cannot receive their grands in any other way, the ABC felt it was a priority to make sure grants for them were available.

In the division below, grants will be divided over the activities from top to bottom. However, should more grants become available, then they will probably be used to undo the decreased number of grants in category A-C first. Hence, no grants are expected for the Sirius Career Days, ConcepT Lustrum Business Course and ConcepT Betonbrouwers activities.

## Board grants (for a 6<sup>th</sup> board member)

In discussion with the other umbrella associations and the Student Union, the OS has been able to secure grants to distribute to associations who have a sixth board member. Under the current FOBOS regulations, board grants are only available for five board members. Therefore, the OS vouched for receiving a number of grants equal to the number of months associations have had a sixth board member. Unfortunately, due to COVID-19 and the distribution of grants to cancelled activities, not enough grants were available to distribute all the 84 grants for this category. The 50 grants that are available have been distributed by ratio and an overview can be found below.

In previous versions of this document, these grants were not taken into account. However, the OS has received the 162 grants available in total partially because these board grants were requested. This means that we are now mandated to distribute these grants in order to prevent a decrease in the total of 162 grants available. Nonetheless, the ABC wants to note that they are of the opinion that it is not the responsibility of the OS to distribute board grants. Board grants are to be determined by the Student Union and the CPO (Commissie Persoonlijke Omstandigheden) and it is their responsibility to issue grants for a potential sixth board member. The ABC therefore pressures the (associations of) the OS to ask the Student Union to change their regulations to allow for a sixth board member to be rewarded under FOBOS category 2 instead of 'Extra & Incidental'.
