Ruben (OSb): The ABC always evaluates what they do, but when associations feel that something should change, they should bring it up so the ABC can evaluate with that.

Nick (ConcepT): For my other question, my concern is that the hours approved is a major 35 thing. How do you prevent associations that apply for more hours than they actually make?

Imke (ABC): What the ABC does is checking the amount of hours based on the proofs. The reason that you submit the proofs is that we can check this.

Ruben (OSb): If you organise an event each year, and the numbers don't match up between the years, we can find these inconsistencies. Also, all the umbrellas need to accept these numbers, 40 so they can also compare and check this.

Nick (ConcepT): Nice to hear that you are aware of this.

Ruben (OSb): Are there any questions about how the distributions of the grants are going?

Sarah (Proto): I did some requests for some committees, one of which was for 2021, but it's not on the list. The study tour was not on the list, neither accepted nor rejected.
