## 1. Opening

#### 2. Setting agenda

#### 3. Announcements

## (a) **OS-board**

- The OS is looking for committee members for the COP (Centrale Onderwijsprijs). This committee organizes the Central Educational Award, which is a prize for the best UT-teacher. Preferably there is one committee member of every faculty. This person does not have to be a board member.
- The deadline for the category 4 activism grants is next Saturday, the 1st of October. The deadline for the category 1, 2 and 3 activism grants is the 1st of November.
- Last year, the GMA has decided that every study association board will get the same amount of activism grands, namely 7 grands per board member with a maximum of 35 per board in total (except for Ideefiks and Onwijs). Due to this, there are only about 130 grants left. This is not enough to give all the applied committees from category 1 to 3 their grants, since only category 1 (study tours) already needs more than 180 grants. The ABC will make several proposals to fix this problem. This proposal will be discussed at the October GMA.

## 5. Alcoholconvenant

(Document: 20160901)

- Sander: The OS has to sent the convenant every half year to all associations, to inform them about this document. Unfortunately, this did not happen last February.
- Proto: If we organize a new kind of committee, does the OS and the Evenementenbureau then have to decide if it is a risk activity or not? Sander: It is stated a little bureaucratic in the document. It is best to just apply the activity at the Evenementenbureau. If they approve the activity, it is okay.
- Where is the white and black list, about which is spoken in the document? Sander: I don't know where it is. I will look it up. **AP Sander: Look up the white and black list for activities and send it around.**
- Onwijs: In the document is stated that in case of high risk activities, the association will together with the Evenementenbureau and HR-VGM have to look at how they can improve the safety at the activity. Isn't it possible to let a specialist check all the drink locations, so that the safety in general can be improved?

Sander: We will look at this! AP OSb: Find out if a safety specialist can have a look at the drink locations.

• Stress: There is a mistake in the calculations of the amount of people that can be in the Educafé in E108.

Sander: Since it is a minor detail, and this document is made up a few years ago with several parties of the UT, this will not be changed.

• Sirius: Will there be IvA courses?

Sander: I have e-mailed the person who coordinates this, but I have no response yet. Probably there will be a course somewhere in the coming two months.

Scintilla: Is there a maximum of persons you can apply for the IvA course?

Jasper: last year it was first dibs, but every association needs to get the possibility to apply people for the course.

ConcepT: Last year, there were way more people than places for the IvA course. Can there be made more spots available?

Sander: Rens has been busy with this last year, but there was not enough budget for it. We will try it again this year.

Proto: We tried to fix IvA courses ourselves, but that was not possible. It all has to go via the OS.

## 6. Evaluation BCC
