De vergunning geldt voor de volgende lokaliteiten:

- De Tap (C5251/C5247 Carré-lokaliteit)	: met een oppervlakte van 72 m ²
- Beneden Peil (C011 Horst-lokaliteit)	: met een oppervlakte van 57 m ²
- Diepzat (C009 Horst-lokaliteit)	: met een oppervlakte van 50 m ²
- EduCafé (E104/E108 Zilverling-lokaliteit)	: met een oppervlakte van 84 m ²
- SmartXP (A138 Zilverling-lokaliteit)	: met een oppervlakte van 316 m ²
- Paradox (1.3.02 Technohal)	: met een oppervlakte van 56 m ²

Voorschriften:

1. De personen die op het vigerende aanhangsel behorend bij deze vergunning als leidinggevende staan vermeld, worden geacht onmiddellijke leiding te geven aan de uitoefening van het horecabedrijf waarvoor deze vergunning is verleend. Dit houdt in dat minimaal één van deze personen, of een bij deze rechtspersoon verbonden persoon die met goed gevolg een IVA-instructie heeft gevolgd, in dit bedrijf aanwezig dient te zijn gedurende de tijd dat dit voor publiek geopend is;
2. Deze vergunning geldt niet voor het houden van bijeenkomsten van persoonlijke aard, zoals bruiloften, verjaardagen en partijen en bijeenkomsten die gericht zijn op personen die niet of niet rechtstreeks bij de activiteiten van de rechtspersoon zijn betrokken.
3. Het openlijk aanprijsen van de mogelijkheid tot het houden van deze bijeenkomsten is niet toegestaan;
4. In de inrichting mag slechts alcoholhoudende drank worden verstrekt gedurende activiteiten die op grond van het bestemmingsplan zijn toegestaan;
5. In de inrichting mag slechts alcoholhoudende drank worden verstrekt gedurende een uur voor tot een uur na beëindiging van activiteiten die op grond van het bestemmingsplan zijn toegestaan en die passen binnen de statutaire doelstelling van de vereniging;
6. Deze horecavergunning of een afschrift ervan dient in de horeca-inrichting aanwezig te zijn.
