#### 5. SUN

a. Harm (SUN): SUN starts with retrieving the Osiris data. The idea is that all associations get as much data as possible, as up to date as possible. The UT normally had the data, and this was strictly regulated and almost impossible for associations to get this data. Ideally, this should be regulated either by a check box on Studielink or you should argue whether your purposes are correct. This should be backed by SUN. A student should apply to SUN and tell SUN they want to become a member of an association, after this the data of that student will be send to the association. This should make it easier for ICT-committees and it would be nice to have one system for all this sharing. SUN will start with only an API and will try to keep it as flexible and minimal as possible. All this will also be integrated with the Union card, so students can buy this in one step and not in multiple steps. Drawback for the UT is that they will become dependent on SUN.

Wouter (Inter-Actief): the only thing relevant would be data being up to date. We would not like the 'become a member' via SUN, we would only like the data. Harm: First we would like to provide associations with relevant data and after this we would like to expand.

Wouter: We would like to see that students can choose to share their data directly with us via Studielink. Harm: This is very complicated and takes a lot of time. An association has its own management, this does mean that you can't simply share data.

Bart (Arago): I would like to take care of the personal data of my members within Arago. First, is it safe? Secondly, can't we make a contract where we ask the student directly for their data, without SUN? Harm: It is secured by LISA, so it is safe. It is possible for associations to ask for data via explicit consent (pop-up).

Hugo (Newton): Delft has the check mark, this is being done for some time now. I think the UT is a bit shocked about the privacy regulation. In Delft, this was already arranged before the big shocker, so it's not easy to do the same here. Often, we do not notice that students dropped out, that's why we support SUN.

Merle (Komma): We are also an association for alumni, how about that? Harm: There has not really been thought about that, but we would like to store the data of new alumni. We are thinking about what to do with the data of alumni who are already alumni now.

Harm: The manifest is to let the UT know that this really is important and that associations see the importance of this as well. The manifest is mainly for getting the data, not whether this is the best form of SUN.

Wouter: It might be that associations have to change their legal documents, if they currently have the obligation to inform members whenever they update their information from an external source (i.e. SUN)

Harm has to leave.

Thomas: We decided to give all associations one grant within category 4.

Hugo: What is the microcontroller course? Koen (Scintilla): This is a 3-day evening course.

Carmen (Sirius): Students in the new system (No basisbeurs) should be considered. Tijmen: The grants are a reward, no compensation.

Hugo (Newton): We get less grants per person, since we have 7 people within the board. Bart (Arago): We have 6 board members, so we get less money as well, while we could not comprehend with 5 people. So, what are you rewarding exactly? I still must pay 300/400 euros to the University. Hugo: Also with 6 or 7 people you can receive so much more. Tijmen: making the association work can be done with minimal effort, which was put on 5 board members. Bart: The grants should reward growth and learning new things. Tijmen: A grant is not for growing, is for either helping the university or for providing for students.

All the collected evidence has been evaluated by the ABC committee to determine the maximum amount of grants that an activity can receive. As it was clear on forehand that not enough grants would be available, category 4 (except for the board grants) has not been taken into account. The total amount of grants required would be 198.

During the Umbrella meeting of November 20<sup>th</sup>, it has been decided that the OS would receive 153 grants from FOBOS "extra and incidental grants" to distribute according to our activism grants model.

The ABC has proposed three different options of distributing the 153 available grants:

- 1. Same weighting factor over all categories
- 2. Different factor for each category (in favour of SRC-trips)
- 3. Top-down approach

Two grants are left-over after these divisions. It is proposed to move these to category 4 and add them to the board grants of Onwijs and Ideefix.
