      - Arago: What's in it for us?

  - e. University Council parties
    - i. Update OER:
      - DAS: Last Monday the OER was disapproved because we did not agree. Last year we approved because we agreed with the good direction, but this year not much was changed, so we voted against. The message should be clear. The one of last year does count now, so nothing changes compared to last year. There will also be a big TOM evaluation.
        - SU: What is the time period of changing the OER?

          DAS: within an hour they will start, so there is a clear path, but we should take care to make sure everything will be done.

## **Contribution Fee (20180503)**

The membership fee, as mentioned in this document, is the amount of money the members of the associations, that are affiliated with the Organisation of Study associations, pay to be a member of the study association. In order to keep the barrier approximately the same for all students to become a member of any association, these amounts and periods are agreed upon during the OS GMA. As of now the following agreements were made.

- -A primary member pays between €8.50 and €10 per year to be a member of their association.
- -A secondary member pays between €4.25 and €5 per year to be a member of their association.
- -A lifelong membership can be offered for three times the primary membership fee, since that is the nominal study period, thus being between €25.50 and €30.

Associations can choose to offer different time periods and these should comply with the abovementioned prices. For example, half a year for a primary member can be offered for a price between €4.25 and €5.

Any additions to this piece can be requested and discussed during the monthly general member meeting of OS.
