Wouter (OSb) (i.a.): We have contacted both the legal department of the university as a notary which has been used by multiple associations. We are currently waiting for a response. We recommend to the associations who are currently in the process of changing their bylaws to explicitly ask the notary to check the construction concerning secondary members. For associations that are not planning on changing the bylaws any time soon, we will keep you up to date concerning the impact of the found problems.

#### 6 Update alcohol regulations

The executive (ed. *leidinggevende*) does not have to be present at the events; you need to be able to call them, but if bartenders with IVA are present, it's fine. The exceptions of the opening hours have been discussed, only one wanted to have it, but it wasn't a big improvement. It would be really expensive and therefore not worth it. So it has been decided that the opening hours won't be extended. The OSb will visit the drinking locations, not as police men, but to check if the requirements are met. The document of the alcohol agreement will be translated.

Jeffrey (Inter-Actief): GMA's end late at night, are we still allowed to have our drinks afterwards?

Hugo (OSb): It is not allowed to have a drink until after 2:00, but it is allowed to have an 5 after-drink with a limited-sized group.

Jeffrey (Inter-Actief): What should we do to exceed the opening times, in case a drinking committee wants this?

Hugo (OSb): It can be done, but then it should be payed by that drinking room and be requested in time.

Rik (Astatine): What are the costs?

Hugo (OSb): It doesn't matter how often this would happen a year. The costs are always around 200 euros.

Peter (Proto): The IVA-bartenders are not the executives. Right?

Hugo (OSb): Yes and officially they need be able to contact the executives.

Ewout (Scintilla): The BOA needs to be able to check behind locked closets, the bartenders, do they need to have the keys for all closets?

Hugo (OSb): It is not a big problem, but think about it!

Hugo (OSb): Henk from the IVA courses spoke also with the municipality and the municipality gave many compliments to us!

Aron (Arago): What happens with the drinks outside of the drinking areas? It is not allowed anymore.

Hugo (OSb): It is technically not allowed, because it doesn't go with our alcohol document. So it is illegal anyhow. There are no official regulations. If those things happen, please tell them to organise it at their drinking areas. In general, the rules are ought to be followed by all parties.

Jelle (Inter-Actief): As long as you don't have to sell drinks, it is allowed to drink everywhere. If you're catering to a certain location, it is fine if you do it without a permit, as long as it's not a general rule.
