6 Update OSFM - Voting

Koen (OSb): We have noticed things have changed. Everything that has been changed this 3 year has been put in the new OSFM. The changes are made in cursive. Are there any questions on how to improve this?

Tijani (Dimensie): Mostly from Ideefiks, for extra and incidental. They can not request for more than 48 weeks. They said they had an application for more than 48 weeks. They want to know if there is an exception for the smaller study associations. It is now an exception each time but can we not make it a rule?

Koen (OSb): You can not work for more than 48 weeks. For preparing and being a candidate board you can not get FOBOS. You have breaks in a year and you do not work for a full 52 weeks. Full-time board members get paid in months and the other categories in weeks which is the case for Ideefiks. We can take it up and see if we can change it, but it is not something for 45 the OSFM.

I was talking about Shell with the building management and we talked about how the university could make a statement about it. As a GMA we could form an opinion towards the university. Couple of weeks ago police got involved in a protest on the O&O square. Maybe not every study association has this problem but it could be.

Chantal (Stress): At other universities, class rooms were taken over. We had to get security. It would be good to have the university form an opinion on how we could work with this.

80 Anna (OSb): I understand more study associations are getting involved with it.

Gert-Jan (ConcepT): I think 2 or 3 study associations have problems now. Maybe you could step to the university and talk about it as a representative for the study associations.

Chantal (Stress): The same with the sustainable account. It is hard to see what is coming towards it and we could make a stance together on it. We heard different things about the paper cups.

Anna (OSb): I talked about it with the SU. The paper cups will not be available at the employee machines, students can pay for the cups. They can have disposables if they drink it somewhere else. This comes in action for 2023. Hopefully, there will be more about it later.

Chantal (Stress): I heard we could sell the cups, which would be okay. Also, that plastic cutlery and plates would not be allowed but paper plates would be allowed.

Gert-Jan (ConcepT): A couple of months ago, I talked about do-groups not talking English and being protected about it. It was then Dagmar was going after it. I was wondering if there was an update about it.

Gerard (OSb): The Kick-In tries to make everyone aware of it and make it inclusive. They monitor it and watch for it. Currently, they are focusing on the winter kick-in. Around march, they will start with the regular kick-in.

Gert-Jan (ConcepT): Specifically, the Kick-In told there were some groups which were allowed to have dutch in their videos. We were obliged to show the videos, but for this time it was okay.

Tijani (Dimensie): Some do-groups would come after the division procedure and say: We would speak English, but people from student associations did not. So they wanted to have English-speaking people in another group. This is not very inclusive and not okay.

Anna (OSb): ICOS is now in close contact with the KIC about international matters.

Franke (Newton): Maybe we can get it this year to have measures instead of them 'looking into it".

Gert-Jan (ConcepT): Action points are not used very much. We could leave it out completely, that is okay. But do we want to use it?
