We are writing this letter to address the problems that we currently see within the alcohol covenant of OS. In particular, one specific point in there. At first glance, it might look like these documents are exactly the same albeit in a different language. While this is true for the most part a minor difference can be found in the "Guidelines for associations" in Appendix 1 of both documents. The document

in English mentioned the following guideline: "The dispensing of alcoholic beverages by bar staff should not take place when the person dispensing the beverages is under the influence of alcohol. "While this cannot be found anywhere in the Dutch version. The next question that


