Provisional distribution Activism grants 2024
ABC committee



The ABC has received all proofs for FOBOS grants from the study associations' boards. These proofs were evaluated in accordance with the OS FOBOS Model (OSFM), with the committee striving to approve as many proofs as possible. While this was successful in many cases, some proofs were rejected due to insufficient documents substantiating the requested hours or non-compliance with the OSFM or general FOBOS rules.

The OS Board will use the divisions outlined in this document during negotiations with other umbrella organizations, following the procedure specified in the OSFM. Please note that the divisions approved by the OS GMA may be subject to changes during negotiations with other umbrellas and the Student Union.

The ABC has observed that several European trips lacked sufficient substantive activities. These trips should focus on broadening academic horizons rather than simply being vacations with recreational activities. We strongly urge associations to carefully review the OSFM and ensure that their proofs align with the outlined expectations, also for other committees.

Additionally, the ABC emphasizes the critical importance of maintaining logbooks, particularly for study tours and IT committees, where it is required for approval by the ABC.

Finally, we must highlight the ongoing importance of adhering to the General Data Protection Regulation (GDPR), as there was a violation again this year, resulting in a strike for one of the associations.

While most proofs have been included in the provisional distribution, some were declined. A summary of these rejections and their justifications is provided in Table 6. For any questions regarding these rejections or the document as a whole, please contact the ABC at abc@os.utwente.nl.

Must Boards Extra

For every month a full-time board has more than five board members, they are eligible for extra grants. Some associations have only had six or more board members for a part of the year, so they only receive extra grants for those months. Part-time boards only receive 7 grants for a full year, which has been taken into account in calculating their extra board grants. For the sixth board member, the OS board can easily defend the necessity of an extra board member. For a seventh or even eighth board member, the grants will land in a lower category.
