

Jelle (OSb): We presented three options in the document:

- Acrap the fee entirely.
- Alter the lower limit.

Jelle (OSb): We suggest leaving the lower limit as it is and raising the higher limit.

Berentio (Newton): Why is there an agreement?

150 Jelle (OSb): This agreement was made so there are not large differences between associations, to have more equality between associations.

Berentio (Newton): We make a lot of money from companies. I can imagine that for other associations it's mostly from membership fees. So that's also not equal.

Sjoerd (Alembic): I think it should be a guideline, not a strict rule, so you have something to adhere to but there could be exceptions.

Nathan Roussel (Scintilla): This is where the purpose from OS comes in so that all associations keep in the general same direction, so that there aren't too big differences between them all. You are free not to keep to it because it is an agreement, not a contract.

160 Thijs (Inter-Actief): Then i want to talk about altering the lower limit, we are looking at making it free to join for master students. We focus mostly on bachelor students, so its unfair to ask the master students the same amount. We notice that many of them do not sign up now. So it would be nice if it could be free for them.

Jelle (OSb): Do other associations have this as well?
