Alcohol meeting covenant. It's a set of rules that the University has for us concerning the alcohol distribution at the University.

We are now on the test period of two years. BOAs can then come to do inspections. We have to follow the rules very tightly during this period. Bar people need to have their IVA certificate, you need to have all the rules printed in the area.

In September we are going to invite a BOA so they can explain what there are going to be looking at. Make sure that all the events are announced?

The last and most important point is that people who are working behind the bar are not allowed to drink alcohol. If this goes wrong, the person gets a fine of 500 euro. If it happens twice, the permit gets placed on hold, if it goes wrong three times, we'll lose the permit.

The OS can also exclude associations that don't follow up to the rules.

Bar committees still can have "naborrels", as long as they are not selling alcohol to members and that there only bar committee members present.
